Please plan to mount your poster using the provided pins on the numbered boards in the lobby in front of Monet 2, any time before the start of lunch on Tuesday, 16 October, 2018 (Place your poster as early as possible for maximum opportunity for poster prize voting)

You may remove your poster any time after 12:00 noon on Thursday, October 18, 2018; posters not removed by 5:30 pm on Thursday, October 18 will be discarded.

Note that the poster session will be open to all ICEVI Conference participants, as well as limited media presence and other visitors, so please carefully consider what information you'd like to include on your poster. Also, note that by registering for this event you consent to being photographed and/or videotaped by the ICEVI East Asia Conference partners on the m premises prior to, during, and immediately after the event. Guidelines for Poster Creation and Presentation

- Each poster should be of A1 print size and will have 2 feet by 3 feet (0.6 meters by 0.9 meters) of space available for display; please make sure your poster fits within this size. Larger posters may not be accommodated.
- Prepare your poster in English; use type and figures large enough to be read from a distance of several feet.
- Please ensure your poster captures the essence of your poster in a form that is understandable to non-experts, as all conference attendees are invited to both poster sessions and will have various levels of expertise in your project area. In particular, please make sure that:
 - (1) the title is readily understandable to lay people,
 - (2) you include a section in the upper right of the poster with one to two sentences in large, bold type that captures the essence of your project in lay terms.
- If you have photos of your work or first-person examples of your project in action, we encourage you to include these on your poster.
